Veterans show up in force to support their VACCC

26 March was another historic day for the Veterans of Cook County. At the quarterly meeting of the Veterans Assistance Commission of Cook County (VACCC), 41 delegates and alternates attended. They represented 32 different eligible veteran organizations. Many guests were also in attendance. Our Superintendent, Elizabeth Soto, gave a detailed report of the expansion of services and workload. The staff of 3 made a herculean effort to serve an estimated 200,000 veterans and their families. Our main concern is to expand this overextended staff in the short term. Other reports where given and nominations and elections held. The new executive board and appointees are named on the **last page**.

Our upcoming meeting Tuesday, 25 June @19hr00 will be very special and we urge all of our veterans community to attend with our delegates and officers. It will be held at Hines VA building 9 (the Auditorium). Before beginning our business meeting, we will have a short presentation by the *Illinois Attorney General's Military and Veterans Rights Bureau*. The MVRB is the only office of its kind in the country and is staffed by veterans.

It is dedicated to ensuring that veterans and active duty military service members receive the benefits they have earned. The bureau provides men and women with assistance; including case advocacy, health outreach, and public advocacy forums. Veterans Legislative Day Springfield



A group of about 45 veterans, took a "road trip" to Springfield on 13 March 2024 to meet with several legislators and advise them in person of our concerns about several bills that are currently pending in the Illinois Senate and the Illinois House of Representative. The trip was the brainchild of and organized by Department Quartermaster/Adjutant, Joe Bartley, with the assistance of Commander Brett Nila and Legislative Committee Chair, Dutch DeGroot. From all parts of the State our veterans arrived and began their day with a breakfast meeting at Springfield's VFW Lafore Lock Post 755.

Comrade Bartley opened the meeting by distributing a worksheet prepared by the Legislative Committee that contained a description and summary of the House and Senate bills that, if passed will impact Illinois vets. The bills of greatest concern were discussed in detail. Our vets were organized into three groups and assigned to meet with certain Representatives and Senators at prearranged meeting times. Those legislators included Sen. Michael Hastings and Sen. Mike Porfirio, the Chairman and Vice Chairman of the Senate Veterans Affairs Committee and several other members of the Veterans Affairs Committee. In the House, our comrades were scheduled to meet with Rep. Lance Yednock, Chairman of the House Veterans Affairs Committee and Vice Chairman, Mark Walker, plus many other members of that committee. Several other influential Senators and Representative also were on the contact list. All of these legislators are especially important because their positions on the bills we are most concerned about will have dramatic effect on whether they are approved the committees. Such approval is required before any bill

can be voted on by the full House or Senate.

Our veterans focused their discussions on two very important bills. The first, SB3479, is an "Anti-Claim Shark" amendment to the Illinois Consumer Fraud and Deceptive Practices Act that requires all business that purport to be able to assist veterans with VA claims must make certain disclosures about their fees and imposes very serious economic penalties for violations. This bill was approved by the Senate Committee, in large part due to a very effective Witness Slip campaign orchestrated by DeGroot. On 9 April 2024, it passed the full House by an astonishing 55-0 vote! The second is a group of related bills in the Senate and House that will provide veterans with service-connected disabilities substantial relief from property taxes on their homes. These bill have not yet been assigned to their respective committees but it is anticipated that will happen soon.

In the late afternoon most of our group assembled on the floor of the Illinois Senate for a group photo with Senator Porfirio. They then adjourned to a local tavern for some oral after action reports. Everyone involved with the trip, especially Comrades Bartley and DeGroot thought their efforts was very effective and were most pleased with the reception by the legislators. They felt that Illinois veterans definitely have "friends in Springfield"! Especially remembered was a comment by Sen. Michael Hastings who said that this was the first time he had ever been visited by an organized group of Illinois veterans to express their positions on pending legislation. Upon leaving his office many of the group were thinking, "but it won't be the last."

Pact Act Facts

Under the PACT Act Expansion, Veterans can qualify for healthcare now if there was a toxic exposure risk activity (TERA) while serving. This is regardless of if they served overseas or stateside only, if the exposure was during active duty, active-duty training, or inactive duty training. If the Veteran was exposed during active-duty training only, they will not qualify under TERA currently.

A toxic exposure risk activity can include:

- Air pollutants (burn pits, sand, dust, particulates, oil well fires, sulfur fires)
- Chemicals (pesticides, herbicides, depleted uranium with embedded shrapnel, contaminated water)
- Occupational hazards (asbestos, industrial solvents, lead, paints including chemical agent resistant coating, firefighting foams)
- Radiation (nuclear weapons handling, maintenance and detonation, radioactive material, calibration and measurement sources, X-rays, radiation from military occupational exposure)
- Warfare agents (nerve agents, chemical and biological weapons); and more.

If the Veteran believes they were involved in a toxic exposure risk activity, then the VA can locate the exposure type in the service record of the Veteran. Additional documents may be needed to support the TERA if not found in the service record, but the Health Eligibility Center will request the documentation.

Veterans who performed active service while assigned to a duty station in (including airspace above) certain locations during specific periods of time: On or after August 2, 1990, in the following countries: Bahrain, Iraq, Kuwait, Oman, Qatar, Saudi Arabia, Somalia, or the United Arab Emirates. On or after September 11, 2001, in the following countries: Afghanistan, Djibouti, Egypt, Jordan, Lebanon, Syria, Yemen, Uzbekistan, or any other country determined relevant by VA can immediately qualify for care. (Note: VA has not determined any other country relevant at this time.)

Veterans who deployed in support of Operation Enduring Freedom, Operation Freedom's Sentinel, Operation Iraqi Freedom, Operation New Dawn, Operation Inherent Resolve, or Resolute Support Mission also qualify under the expansion for VA care.

Minimum eligibility requirements must still be met to qualify for healthcare.

With the expansion on the PACT Act benefits, several Veterans may qualify for immediate care under TERA, or the added locations of service and Operations instead of having to file for a service-connected rating or waiting to be phased in based on separation from service.

Landmark decisions effecting Chicago V eterans



The Mayor's Office of Veterans Affairs celebrated a historic milestone last week with the passage of the Veterans Hiring Preference by the Chicago City Council. Sponsored by Alderman Villegas, Chair of the Council's Veteran Caucus and a former U.S. Marine, this significant amendment extends a hiring

preference to veterans across all city departments, encompassing all job categories within Chicago. This ensures that veterans receive priority consideration during the selection process.

The amendment, which required months of collaborative effort between the Mayor's Office of Veterans Affairs, the Department of HR, the Law Department, Alderman Villegas' team, and other stakeholders, includes updates such as expanding the definition of a veteran to encompass National Guard members and reservists, thereby broadening the scope of those eligible for the hiring preference.

Iam proud of the many achievements this administration and the Mayor's Office of Veterans Affairs has already accomplished in less than a year. From providing access to affordable housing, improving access to earned benefits, creating pathways to employment opportunities, or expanding opportunities for veteran-owned businesses, our efforts will have a lasting effect on our veterans and their families for years to come.

This means that all Veterans who served in the Vietnam War, the Gulf War, Iraq, Afghanistan, the Global War on Terror, or any other combat zone after 9/11 will be eligible to enroll directly in VA health care without first applying for VA benefits. Additionally, Veterans who never deployed but were exposed to toxins or hazards while training or on active duty in the United States will also be eligible to enroll.

As directed by President Biden, this expansion of VA health care eliminates the phased-in approach called for by the PACT Act — meaning that millions of Veterans are becoming eligible for VA health care up to eight years earlier than written into law. This is a critical step forward because Veterans who are enrolled in VA health care are proven to have better health outcomes than nonenrolled Veterans, and VA hospitals have dramatically outperformed non-VA hospitals in overall quality ratings and patient satisfaction ratings. Additionally, VA health care is often more affordable than non-VA health care for Veterans. VA encourages all eligible Veterans to visit VA.gov/PACT or call 1-800-MYVA411 to learn more and apply for VA health care beginning March 5. Since President Biden signed the PACT Act into law on August 10, 2022, more than 500,000 Veterans have enrolled in VA health care. "If you're a Veteran who may have been exposed to toxins or hazards while serving our country, at home or abroad, we want you to come to us for the health care you deserve," said VA Secretary Denis McDonough. "VA is proven to be the best, most affordable health care in America for Veterans - and once

you're in, you have access for life. So don't wait, enroll starting March 5th." Beginning March 5, we're making millions of Veterans eligible for VA health care years earlier than called for by the PACT Act," said VA Under Secretary for Health Shereef Elnahal, M.D. "With this expansion, VA can care for all Veterans who served in the Vietnam War, the Gulf War, Iraq, Afghanistan, the Global War on Terror, or any other combat zone after 9/11. We can also care for Veterans who never deployed but were exposed to toxins or hazards while training or on active duty here at home - by working with chemicals, pesticides, lead, asbestos, certain paints, nuclear weapons, x-rays, and more. We want to bring all of these Veterans to VA for the care they've earned and deserve." In addition to expanding access to VA care, this decision makes it quicker and easier for millions of Veterans to enroll. Many Veterans believe they must apply to receive VA disability compensation benefits to become eligible for VA health care, but this is not correct. With this expansion and other authorities, millions of eligible Veterans can enroll directly in VA care – without

any need to first apply for VA benefits. This expansion of care covers Vietnam Veterans, Gulf War Veterans, Iraq War Veterans, Afghanistan War Veterans, Veterans who deployed in support of contingency operations for the Global War on Terror (Operation Enduring Freedom, Operation Freedom's Sentinel, Operation Iraqi Freedom, Operation New Dawn, Operation Inherent Resolve, and Resolute Support Mission), and more. This expansion also covers many Veterans who never deployed as a part of a conflict but were exposed to toxins or hazards while serving in the U.S. Specifically, under this expansion of care, any Veteran who participated in a toxic exposure risk activity (TERA) — at home or abroad – is eligible for VA health care. VA has determined that Veterans who were exposed to one or more of the following hazards or conditions during active duty, active duty for training, or inactive duty training participated in a TERA:air pollutants (burn pits, sand, dust, particulates, oil well fires, sulfur fires); chemicals (pesticides, herbicides, depleted uranium with embedded shrapnel, contaminated water); occupational hazards (asbestos, industrial solvents, lead, paints including chemical agent resistant coating, firefighting foams); radiation (nuclear weapons handling, maintenance and detonation, radioactive material, calibration and measurement sources, X-rays, radiation from military occupational exposure); warfare agents (nerve agents, chemical and biological weapons); and more. VA will use all available information to determine if Veterans participated in a TERA, including military records and service connection. VA is executing a nationwide campaign to ensure that as many Veterans as possible enroll. To date, VA's PACT Act outreach campaign has included more than 2,500 events nationwide, \$13 million in paid advertising, 88,000 earned media clips, more than 400 million emails and letters to Veterans, VA's firstever text messaging campaign, the creation of a one-stop-shop PACT Act website, and more. This is the largest outreach campaign in VA history, which has one goal in mind: ensure that all Veterans —and their survivors — get the health care and benefits they deserve under the PACT Act.
